In consideration of the mutual benefits derived from the joint participation by membership in the Southern Snow Seekers Ski Club I skiing and all other activities, the undersigned do(es) hereby absolve, release, and waive any and all liability, claims, or demands against the Southern Snow Seeker Ski Club and its officers, and each and every member thereof which may arise out of or be related to any injury, damage, pecuniary loss by reason of such club membership or activity of or participation in said organization. Included, but not limited to this general release, are all causes arising of nonfeasance, malfeasance, or negligence of the Ski Club and its officers. The undersigned, as father and mother and/or guardian(s) of the above named children, for the considerations set forth above, do hereby further release, acquit, discharges, and covenant to hold harmless the Southern Snow Seekers Ski Club and its officers, and each and every member thereof from any and all liability, claims, or demands arising out of or from participation in said Club or related activities by said minors.
